Let me first preface this proposal with this addition not being directed at any single member of the executive council nor any single officer.

I believe this addition to the bylaws is needed for efficiency within the council and for the club as a whole.

We elect officers and members of the executive council for their fervor, their opinions and standards in the form of votes and discussion and also for their dedication to the club.

Currently, the way the bylaws read, a member of the executive council can accept nomination and become a member but there is no standard of attendance for elected positions that are not officer positions and I seek to change that with this proposed addition to article 4. this addition will simply hold all elected positions to the same attendance standard of not missing more than 3 consecutive meetings. I believe that if an elected position can no longer attend meetings and perform the duties of said position, the member should submit a letter of resignation to the president for acceptance and resign from the position to allow another full member to be nominated and elected so the council or office can resume their duties at full capacity as intended in the club constitution.

Please consider this my proposal.

Proposal for CWVWA By-Laws/Constitution change Proposed at Monthly Meeting October 14, 2023:

Article IV Executive Council currently reads:

The executive Council shall have the authority to plar Association activities and to conduct Association business except for those items of business reserved for the Full Membership by the Constitution and By-Laws of the Association. Decisions made by the Executive Council, acting within its authority, shall require concurrence of a majority of the Executive Council members in attendance, any decisions will be recorded by the Association secretary and presented at the next regularly scheduled Association Meeting for discussion and possible approval. The Executive Council shall also perform a review of assets in December of each year.

* Article IV Executive Council proposed addition:

In addition, the elected Executive Council members shall be held to the same attendance standard as referred to in Article III, Section 5a, wherein being absent from 3 consecutive meetings shall constitute a forfeiture of the members position and the membership will choose a replacement for the position at an Association meeting.
